

# Board of Directors January 16, 2019

#### SUBJECT:

Approve Map and Legal Descriptions and Authorize Staff to Distribute Funds Necessary to Cover Agency Fees Pertinent to the Annexation; and Adopt Two Proposed Resolutions for the Annexation of Parcel Nos. U-23-18-6 and U-24-18-6 (Riverside Mitland 03, LLC)

### **BACKGROUND:**

In accordance with the provisions of Resolution No. 2063.7, the Board established standard terms and conditions for the annexation of land to an Improvement District or Improvement Districts of Eastern Municipal Water District. The owner of the involved parcel of land, Riverside Mitland 03, LLC, an LLC controlled by Brookfield Southern California Land, LLC, which is primarily owned by David E. Bartlett and Richard T. Whitney have submitted a duly executed standard form Petition to the District requesting annexation of the 72.99 acre parcel of land, as shown on the attached map (Exhibit C). The parcel has been designated as Parcel Nos. U-23-18-6 and U-24-18-6 to Improvement District Nos. U-23 and U-24. All necessary ownership documentation, as provided for in said Petition, are on file with the District, and payment of the applicable annexation fees totaling \$14,598.00 for both sewer and water has been made in addition to the applicable State Board of Equalization fees.

#### FINANCIAL IMPACT:

Annexation fees have been paid as noted above; annexation into the improvement districts will cause the property to be included in tax assessments set annually by the Board of Directors.

U-23-18-6 and U-24-18-6 to Improvement District Nos. U-23 and U-24 of the Eastern Municipal Water District.
