SUBJECT:

Approve Map and Legal Descriptions, and Adopt Two Proposed Resolutions for the Annexation of Parcel Nos. U-27-20-8 and U-28-20-8 to Improvement District Nos. U-27 and U-28 (CLPF Heacock Street, LP)

BACKGROUND:

In accordance with the provisions of Resolution No. 2063.7, the Board established standard terms and conditions for the annexation of lands to an Improvement District of Eastern Municipal Water District. The proposed Resolutions annexing Parcel Nos. U-27-20-8 and U-28-20-8 to Improvement District Nos. U-27 (sewer) and U-28 (water) are attached as (Exhibits A and B). The parcel is located in the City of Moreno Valley, County of Riverside, as depicted on the attached legal descriptions and map (Exhibit C). EMWD has received a signed petition from the current property owner, CLPF Heacock Street, LP, with John M. Clinton as the authorized signer. All necessary ownership documentation are on file with the District.
