<b>AB 11</b> Chiu (D)	<b>Community Redevelopment Law</b> Authorizes a city or county or two or more cities acting jointly, to propose the formation of an affordable housing and infrastructure agency by adoption of a resolution of intention. Provides for a governing board of the agency. Requires the agency to submit an annual report, and final report of any audit undertaken to its governing body. Requires the governing board of an agency to designate an appropriate official to prepare a proposed redevelopment project plan.	<b>EMWD: Pending</b>  <b>Status:</b> 12/03/2018 - INTRODUCED.
<b>AB 129</b> Bloom (D)	<b>Waste Management: Plastic Microfiber</b> Declares the intent of the Legislature to, among other things, enact legislation to recognize the emerging threat that microfibers pose to the environment and water quality and makes related findings and declarations.	<b>EMWD: Pending</b>  <b>Status:</b> 12/04/2018 - INTRODUCED.
<b>AB 134</b> Bloom (D)	<b>Safe, Clean, Affordable, and Accessible Drinking Water</b> States findings and declarations relating to the intent of the Legislature to adopt policies to insure that every Californian has the right to safe, clean, affordable, and accessible drinking water.	<b>EMWD: Pending</b>  <b>Status:</b> 12/05/2018 - INTRODUCED.

<b>SCA 3</b> Hill (D)	<b>Property Taxation: Change in Ownership: Exclusion</b> Limits the \$1 million exclusion for purchases or transfers of real property other than a principal residence to purchases or transfers of nonresidential real property. Provides that the transfer of the principal residence of a parent or grandparent is excluded from purchase or change in ownership under these provisions only if the transferee uses the residence as his or her principal residence within 12 months after the transfer.	<b>EMWD:</b> <i>Pending</i>  <b>Status:</b> 12/04/2018 - INTRODUCED.
